## SECTION 5 FIRE FIGHTING MEASURES

### 5.1 Suitable extinguishing media

Suitable: Water spray, alcohol-resistant foam, dry chemical, carbon dioxide or appropriate foam. For small fires, use media such as “alcohol” foam, dry chemical or carbon dioxide. ### 6.1 Procedure of Personal Precaution
