SECTION 5 FIRE FIGHTING MEASURES

5.1 Suitable extinguishing media

Suitable: Water spray, alcohol-resistant foam, dry chemical, carbon dioxide or appropriate foam. For small fires, use media such as “alcohol” foam, dry chemical or carbon dioxide. SECTION 6 ACCIDENTAL RELEASE MEASURES

6.1 Procedure of Personal Precaution

Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Beware of vapors accumulating to form explosive concentrations. Vapors can accumulate in low areas.
